## Membership Application Guidelines & Policies

- Waiver – not required
- Proposer/Seconder – required, at least 2 years proprietary member of the Club plus 5 club members known to the applicant
- Posting period – 30 days
- Schedule of interview – within the 60 days posting period
- Membership Card – applicant's temporary card will be issued during the posting and interview period, 4 months permanent card.
- Stock Certificate – 1 month.
- Dependents' age limit: unmarried sons: up to 25 years old/ unmarried daughters: regardless of age
- Jr. Membership – 26 to 45 years old
- 50% discount on entrance fee for transfer of share to immediate family
- A regular proprietary member in good standing for 35 continuous years becomes an honorary member and he will be exempted from paying the monthly dues and patronage fee. Company assignee is allowed to be an honorary member.
- For Company Membership: Company should have been existing for a minimum of three (3) years including the Company Assignee, at the time of the application for membership
- The Company Assignee must be a bonafide executive, specifically owner of the corporation (those owning 5% plus one share of the Corporation), Chairman of the Board, President and CEO, Vice President and Treasurer, retained professional of the company- applicant, or top three (3) positions of the Company or member of the Board of Directors
- For lost Stock Certificate: There is a standard format for the NOTICE OF LOSS to be published by the newspaper company
